Mrs. X. ... So what did you buy? Mr. X. You are going to like this! Mrs. X. What? Is it for me? Mr. X. You will really like this. Mrs. X Diamonds? That big diamond necklace? Mr. X. Actually, grills. Mrs. X. ... You bought ... grills? Mr. X. Yeah, but these are fantastic grills. Mrs. X. What kind of grills? Mr. X. Well one is a B grill. Mrs. X. What? Mr. X. A B grill. Mrs. X. We don't grill bees.
